## FINAL REPORT

During my research stay at the Open Society Archives from June, 1 - July 31, 2014 I have been working on three projects<sup>1</sup>. The first project was entitled: Situation of drug users in communist societies – developing a better understanding of the past, the present and the future through evaluating human rights reports. In conducting the study I relied on available at OSA human rights reports, medical/public health information on drug use (including the issue of HIV/AIDS among drug users), reports on drug use as a violation of criminal provisions in communist states, and conditions in prisons (particularly as regards to health issues). Based on the research I prepared an article: Delivery of health services to imprisoned drug users in post-communist countries – developing a better understanding of the past, the present and the future through analysis of legislation and practice in Poland. In the article I presented a comprehensive overview with regard to the legislative situation of delivery of health care services to drug users in prisons in Poland.

In order to get a picture of a health situation in prisons during this period I looked into: Records of the Radio Free Europe HU OSA 300-7-10-7 (prisons), HU OSA 300-7-8-9 (Yugoslavia prisons), HU OSA 300-7-24 (Czechoslovakia prisons), HU OSA 300-7-6-28 (USRR prisons), HU OSA 300-7-4-6 (Bulgaria prisons), HU OSA 300-7-3-11 (Romania prisons), HU OSA 300-7-2-13 (Poland prisons), HU OSA 300-7-1-14 (Hungary prisons), HU OSA 300-10-3-61, HU OSA 300-10-2-346, HU OSA 300-10-2-347 (Yugoslavia prisons). I also examined articles in the following journals: Human Rights in USSR 1972-1975, Amnesty Action, Amnesty International Newsletter 1973-1993, Human Rights Watch 1985-1993, Problemy alkoholizmu 1971-1989.

The second research project is a book chapter on transformation of the freedom of speech in Poland entitled: *Revolution of evolution? Structural transformations towards freedom of speech in Poland in the years 1989-1992*. It describes legal developments of the right to free speech in Poland during the period of transformation, and presents the legal and structural reforms from 1989-1992 in their social context. To complete the article I consulted following archives: **HU OSA 300-50-1-159**, **HU OSA 300-50-1-160** and **HU OSA 300-50-1-161 (107.2)**.

The third research project is entitled: Crimes of Hate or Acts of Mercy? Legal Evaluation of Contemporary Cases of Non-Consensual Sterilizations of Romani Women in Central European Countries. This project will provide a comparative picture of the laws and policies governing sterilization in Hungary, Czech Republic and Slovakia and
